# **EXECUTIVE SUMMARY**

The United Nations Global Compact Leaders Summit 2013: Architects of a Better World, held in New York on 19-20 September 2013, brought together chief executives with leaders from civil society, Government and the United Nations to unveil the **Business Engagement Architecture** to align and scale up business action in support of sustainable development priorities. Chaired by UN Secretary-General Ban Ki-moon, the Leaders Summit provided a platform for 1,200 participants to discuss corporate sustainability strategy at the highest level and produce strategic recommendations and action imperatives for the future of the initiative.

Held every three years, the Leaders Summit is the largest gathering of its kind. The Leaders Summit looked to the vision and aspirations of the first United Nations members in 1945, as they set out to be "architects of a better world", through the lens of thousands of companies that have become key partners in tackling our world's most pressing challenges. Now, as the Millennium Development Goals 2015 deadline approaches, Governments and the UN are working to set global priorities for the post-2015 period. The post-2015 era presents a historic opportunity for the international business community to contribute to the attainment of worldwide sustainability and development objectives.

At the Leaders Summit, it was clear that progress has been made within the business community to orient towards sustainability. Participants recognized that the challenge ahead is to transition from incremental progress to transformative impact on markets and societies. By aligning and scaling up corporate sustainability efforts, the Business Engagement Architecture will help business to contribute to global priorities — such as climate change, water, food, women's empowerment, children's rights, decent jobs and education — at unprecedented levels. With an emphasis on collaboration and co-investment, the Architecture illustrates the main building blocks necessary to enhance corporate sustainability as an effective contribution to sustainable development, creating value for both business and society. The Leaders Summit set in motion a process to strengthen these building blocks through a comprehensive and collective effort to take corporate sustainability to scale in the post-2015 era.

# Unveiling the Vision

# **Opening Plenary**

The Leaders Summit was opened by UN Secretary-General Ban Ki-moon. The Opening Plenary was designed to connect participants to the urgent challenges of our time and show that transformation to a better world is possible when we take action, both individually and together. After the Architecture was unveiled by the Secretary-General, speakers elaborated on its components and its potential to help unleash massive business in action in support of sustainable development — now and in the post-2015 era. *See page 12*.

### Interactive CEO Panel

Using an interactive format to exchange views between the audience and the panel of leading CEOs, the session explored the top drivers — both material and moral — for businesses to integrate responsible practices into their operations and take action on sustainability issues. # Architects of a Better World: Closing Plenary

The Closing Plenary called on a new coalition of Architects of a Better World — beginning a process of engaging companies and key stakeholders in the Architecture. Panelists presented new issue platforms — on peace, education and sustainable agriculture and a corporate sustainability programme for Boards of Directors. The Global Compact, together with the World Business Council for Sustainable Development and (WBCSD) and the Global Reporting Initiative (GRI), invited all organizations to join forces to strengthen and implement the Architecture. UN Deputy Secretary-General Jan Eliasson provided closing remarks and urged business to actively engage in shaping and implementing the post-2015 agenda. *See page 26*.

# **EVENT SUSTAINABILITY**

The Global Compact, in cooperation with sustainability experts at event management company MCI, implemented a comprehensive sustainable event strategy to improve the delegate experience and to address the environmental, social and economic impacts of the Leaders Summit. Key highlights included:

## **1. A PAPER-SMART EVENT**

The Leaders Summit limited printed materials such as publications, background materials, agendas, and instead relied on a customized mobile application.

## 2. SUSTAINABLE CONSTRUCTION

The Action Fair booths used substrates made from recycled materials and were recycled. No acrylics, vinyl or PVC were used in the event branding, and the  $81m^2$  of signage produced was made from Eco-Board and was fully recycled.

## **3. REDUCED WASTE**

An estimated 15.6 tons of waste was produced as a result of the Leaders Summit. 20 percent of waste was diverted away from landfill. Waste management strategies included the use of reusable materials for the stage set, elimination of bottled water, and the serving of food and beverages only using reusable glass, crockery or cutlery.

## **4. SUSTAINABLE FOOD**

A focus was placed on offering food and beverage options that used a healthy combination of fresh, local, organic, sustainable and seasonal ingredients. Out of the 8,600 food services, approximately 40 percent at the Leaders Summit venue and 90 percent at the Leaders Dinner venue were sourced from farms within 100 miles. 35 percent of the food served was vegetarian and approximately 20 percent was organic.

#### **5. PROCUREMENT**

Over 50 percent of supplier contracts included sustainability clauses. Increased performance could have been realized if the venue contract had included stricter requirements for recycling and reporting.

#### 6. EMISSIONS

Total emissions for the event were 1,931 tons of carbon dioxide equivalents tCO<sup>2</sup>. As with most international events, the biggest emissions impact (95 percent) resulted from air transport of conference delegates, while public transport, waste and energy use at the venue only contributed a relatively small share of the overall emissions.

#### 7. OFFSETTING

205 participants elected to voluntary offset their travel emissions. Consequently 307.5 tCO<sup>2</sup> of carbon credits were purchased in the Carbon for Water project, a partnership between Vestergaard Frandsen and ClimateCare. Carbon for Water uses carbon financing to sustainably provide 4.5 million people in Kenya with the ability to purify water in their homes via the LifeStraw <sup>®</sup> system – avoiding the need to burn fuel from unsustainable sources that contribute to greenhouse gas emissions. This award winning project is certified to the Gold Standard for Verified Emission Reductions.

100 percent of the Leader Summit's electricity footprint, including event preparations, power usage at the Grand Hyatt New York and electricity used at social events were offset through the purchase of Gold Standard premium quality renewable energy projects by UN partner WindMade.



A customized Leaders Summit mobile application provided attendees with up-tothe-minute information regarding agendas, speakers, venues and more. Participants also used the app to connect with other attendees, interact during sessions, explore exhibitors and access relevant publications and resources.



# OPENING THE VISION: ----



The UN Global Compact Leaders Summit 2013 began with an Opening Plenary that set the stage for the event to explore how business can shape and advance sustainable development beyond 2015 and marked the launch of the Business Engagement Architecture. The session began with an opening video designed to inspire Leaders Summit participants first as individuals and human beings, as well as business executives. The video incorporated both historical leaders of change and presented a vision towards the future we hope to achieve if people come together on critical priorities.

**Tererai Trent**, Founder of Tinogona, embodied this spirit of hope, possibility and the power to realize change through action. She shared her personal story of overcoming fundamental barriers — poverty, gender discrimination and education — to achieve her goals and ultimately work to make a positive impact in her community and beyond. Gender equality and education are fundamental to progress. Ms. Trent has seen this first-hand growing up and now in her efforts to uplift communities that continue to suffer from lack of inclusion, prosperity and opportunity. The message was clear: individual action can turn into collective movements — and achieve changes never thought

possible. Ms. Trent called on participants to take action as individuals, as well as in their companies, to unlock the potential of the developing world and work towards a more sustainable and equitable world.

UN Secretary-General Ban Ki-moon welcomed the diverse group of leaders from business, civil society and Government. He underscored the importance of collaboration and highlighted the significant progress made towards eradicating poverty and disease as evidence of what can be achieved. He noted, however, that inequality persists and can only be overcome if all stakeholders act together. The Secretary-General stressed the key role of the Global Compact in helping business to become a key partner of the UN and recognized the initiative's growth to 8,000 participating companies and 4,000 civil society signatories in 145 countries, as well as its 101 country networks. The Secretary-General announced that three new Global Compact issue platforms – on Education, Business for Peace and Sustainable Agriculture – would be launched at the Leaders Summit and recognized existing initiatives – Caring for Climate and the Women's Empowerment Principles – as the world's largest business action platforms in their fields.



The Secretary-General noted the importance of business in accelerating the Millennium Development Goals (MDGs) and emphasized that business should play an even more integral role in shaping and implementing the post-2015 development agenda. The Secretary-General unveiled the Business Engagement Architecture to scale up corporate sustainability and align business with sustainable development priorities. He welcomed the support of WBCSD and GRI for the Architecture, which invites corporate leaders to collaborate and co-invest to share risks and realize opportunities. The Secretary-General called on each participant to be an architect of a better world and respond to the urgency of our global challenges.

Amina Mohammed, the Secretary-General's Special Adviser on Post-2015 Development Planning, John Ruggie, Berthold Beitz Professor in Human Rights and International Affairs at the Harvard Kennedy School of Government, and Georg Kell, Executive Director of the Global Compact, presented elements of the Architecture. While Government must create an enabling environment for the realization of the post-2015 agenda, there is a key role for business in implementation and the Architecture provides the platform. It will allow business to not only scale corporate sustainability efforts and practices, but also to spread them to others through their relationships and by setting positive examples. The UN is increasing efforts to create more space for business to engage in the post-2015 agenda, and the Architecture has potential to help strengthen global governance systems as challenges ranging from the environment to financial markets continue to span borders.

The Architecture is closely connected with the universal principles advanced by the Global Compact and links UN goals directly with long-term business goals. Examples of the Architecture's platforms for action and partnership include the Global Compact's 101 Local Networks, issue platforms and new technology-powered Business Partnership Hub. Key drivers of corporate sustainability — for example investors engaged with the Principles for Responsible Investment (PRI) and academics in the Principles for Responsible Management Education (PRME) — and the Architecture's emphasis on transparency and public commitments were also highlighted.



# INTERACTIVE CEO PANEL



During the Interactive CEO Panel, participants considered the moral and material imperatives to move corporate sustainability from individual projects and programmes to the heart of business. The discussion was informed by the findings from the UN Global Compact CEO Study 2013 conducted with Accenture. Following a panel discussion among five leading CEOs from around the world, participants in the audience engaged in roundtable discussions. Representatives of labour, the investor community and civil society also provided their perspectives.

# **Presenting the CEO Study**

The UN Global Compact CEO Study 2013 conducted with Accenture features the perspectives of over 1,000 chief executives on what is needed for corporate sustainability to have a transformative impact on markets and societies. The study has been conducted every three years since 2007 and the third edition launched at the Leaders Summit continues to demonstrate broadening awareness on the part of global business of the opportunities presented by sustainability. Amid evidence that CEOs are strongly committed to embedding sustainability throughout their organizations, the vast majority now call for action to incentivize and reward sustainability leaders and unlock the full potential of the private sector. According to the study, more than two thirds of chief executives — 67 percent — believe that business is not doing enough to address global sustainability challenges. The Architecture presents a way forward to drive and scale up corporate sustainability actions that CEOs are calling for.

# Aligning the Values of Business and Society in the Long-Term

For more than a decade, the Global Compact has played an important role in mainstreaming universal principles into the strategies and operations of businesses around the world. The initiative's growth to over 8,000 business participants demonstrates that an increasing number of companies are integrating sustainability. Panelists stressed that the world must go even further. Instead of changing programmes and companies alone, there needs to be a greater transition of the system in which the world operates to better align with universal values and a long-term perspective.

Participants agreed that business and society are interdependent, and sustainable development priorities are closely linked with long-term business goals. Business is in fact working for all of society generating material wealth as well as positive and negative impacts on people and the environment. Understanding this perspective encourages business to prioritize long-term rather than short-term gains. In order to successfully manage a business, leaders must think beyond the next one or two quarters, and it is impossible to do so without considering sustainability. The importance of engaging youth in sustainability as well as the number of youth that want to advance sustainability — was emphasized.

## **Driving Sustainability Performance**

As presented in the Architecture, a number of societybased and market-based drivers are motivating more and more companies to take action that advances sustainable development, continuously strengthening the "business case" for corporate sustainability.

The call for more corporate sustainability leaders was made yet again, and the bar for sustainability performance is being set higher and higher. Companies who truly integrate sustainability have the ability to tackle enormous global challenges — poverty, food security and disease among others — in ways that pilot programmes and philanthropy cannot. A small number of companies make up an overwhelming proportion of the global economy, and if those companies embrace sustainable development, much can be achieved. Leaders also have the opportunity leverage data about corporate sustainability to make the case both internally and externally. Measuring and collecting data on sustainability outcomes is critical to improving performance.

Employees and labour groups are demanding decent jobs and fair wages as well as a greater sense of purpose at work. As the world works to add 600 million jobs in the next ten years, it will be critical to reduce the number of vulnerable jobs and youth unemployment. Challenges such as extremely low wages and dangerous working conditions were also highlighted this year by the tragedy at Rana Plaza in Bangladesh, driving business to address sustainability in global supply chains. Companies can also better engage their employees by aligning the companies' values with their personal goals to positively impact the world.

Consumers and citizens have an enormous opportunity to make their voices heard and accelerate the pace of change. Companies must listen. Around the world, recent social movements and regime changes have been driven by citizen movements. How companies design and develop products and services, and communicate this to consumers, are sure to be critical questions in the coming era.

Investors are driving companies to take a long-term perspective, which closely links both profitability and social good. Like companies, investors also have access to an unprecedented amount of data and they are requesting more information on how investee companies are managing environmental, social and governance risks. At the same time, patient capital investments, especially in entrepreneurs or in the poor, take on more risk but can have greater rewards in the long run.

Civil society plays an important role in shedding light on critical issues and collaborating with business to address them. Panelists emphasized gender equality as a key element of sustainable development. Civil society also works with business to address other broad challenges including climate, water, food, children's rights, decent jobs and education. Finally, Africa was highlighted as a region where implementing responsible business practices is more critical than ever for achieving long-term growth.

# BUILDING BLOCKS: EXECUTIVE SESSIONS



In smaller break-out groups, participants focused on components of the Architecture that have high potential for scale, collaboration and impact. During these highly interactive, world café-style sessions participants discussed key challenges and opportunities for leveraging each mechanism to advance global priorities.

The Executive Sessions focused on the following six areas:

# Collective Action and Global Issue Platforms

Participants discussed major business-oriented initiatives that are aligned to specific global challenges and how these efforts can deliver even more impact in the future, both individually and via collaboration. Discussions were centred on global priority issues areas. Participants indicated that Global Issue Platforms should place a greater emphasis on facilitating action among participants and stakeholders. Further, the importance of profiling good practices in terms of innovative policies, standards, technologies, services and products was underscored as a critical motivator for triggering systemic change.

## **UN-Business Partnerships**

This session identified how business actors and other stakeholders can more effectively partner with UN entities in the post-2015 era across global priorities and themes - in order to achieve transformational impact. On both sides, the capacity and willingness to partner has grown substantially over the past decade. Today there are many entities throughout the UN system that have the capability to partner, and comprehend business and market realities. On the business side, there has been a shift from chequegiving partnerships to harnessing core business expertise. Three buckets of UN-Business partnerships which, with greater scale, could have the most positive impact were identified: delivering products and services, advocacy and trust building, and creating a more rigorous enabling environment.

## **Business Sector Initiatives**

Business and sector initiative leaders together uncovered opportunities to increase the efficiency and efficacy of sector initiatives (especially through the supply chain) and explored opportunities for collaboration. Participants discussed the importance of building trust among stakeholders through accountability and transparency. As companies across a given sector often share the same goals and challenges, the potential for success in working together is great. Sector initiatives should also explore how they can together more comprehensively address global issue priorities.

# **Local Sustainability Movements**

Focused on how to enhance the role and contribution of structures such as Global Compact Local Networks, this session explored the strategic and tactical considerations for creating more vibrant national-local sustainability movements to widen and deepen impact, including through policy engagement. Participants highlighted that local sustainability movements in general usually arise from the needs expressed by their members. Discussions and efforts related to the design and implementation of development goals often remain with national-level government institutions. As a bottom-up process, sustainable development starts at the grassroots level where local initiatives and policies can deliver powerful leverage and will often have the most impact.

### **Private Sustainability Finance**


Participants examined the ways that private providers of finance and capital can strategically contribute to sustainable development priorities, with a focus on scaling impact. Private providers of finance including institutional and retail portfolio investors, banking and project finance providers, insurance underwriters, foundations/philanthropic organizations, and major corporations through foreign direct investment. Focusing on how these institutions can be leveraged to meet both financial and social objectives, participants emphasized the need for financial literacy to include ESG considerations. Further, partnerships at the local level are key to cultivating innovation from the ground up. Additionally through partnerships respective knowledge, resources and capacity can be effectively leveraged.

# Horizon Session: The Business Enterprise in 2100

This free-form session examined the evolving role of business in society and what new business enterprises and models might — or should — emerge in the coming decades in order to address some of the persistent trust tensions between the private sector and society at large. Anchoring the conversation on disruptive forces that could indeed change business models, participants emphasized the need for a cultural and value change, one where there is a transition from wealth maximization to social maximization. Additionally, the importance of moving away from hierarchical organizing and decision making to an approach that facilitates greater bottom-up processes was underscored, such as dialogue with employees to test new models of engagement.











# ARCHITECTS OF A BETTER WORLD: CLOSING PLENARY

The Closing Plenary looked back on the day's events and called on participants to form a new coalition of architects of a better world. It launched a process of engaging companies and key stakeholders in the Architecture — aligning business with sustainable development priorities leading up to 2015 and beyond.

## A Comprehensive Menu of Issue Platforms

Issue platforms address the heart of the post-2015 development agenda. Already, the Global Compact has Caring for Climate, the Women's Empowerment Principles, CEO Water Mandate, Children's Rights and Business Principles, working groups on both Anti-Corruption and Human Rights and Labour, as well as sister initiatives, PRME and PRI, to engage business schools and investors. There are also a wide range of issue platforms outside of the Global Compact. However, the Global Compact has identified gaps and in order to present business with a comprehensive range of engagement options, the Leaders Summit marked the launch of the following:

#### **Business for Peace**

The Business for Peace platform aims to expand and deepen private sector action in support of peace — in the workplace, marketplace and local communities. The platform assists companies in implementing responsible business practices aligned with the Global Compact ten principles in conflict-affected and high-risk areas and catalyze action to advance peace. Objectives include mobilizing corporate leaders to advance peace through actions that help to build strong economies and prosperity, establish more stable and just societies, foster tolerance, and create trust and intercultural understanding.

#### Education

Together with UNICEF, UNESCO and the UN Special

Envoy for Global Education, the Global Compact has developed guidance for engagement by business to create education and learning opportunities for children, youth and adults. The framework helps companies identify the business case and develop engagement activities in a responsible manner.

#### Sustainable Agriculture Business Principles

Developed in collaboration with key civil society organizations and experts, the Sustainable Agriculture Business Principles will articulate a common understanding and agreement on the resources, ecosystem services and socio-economic impacts needed to build resilience into agricultural supply systems and the markets that they serve. The Sustainable Agriculture Business Principles will also support the objectives of relevant UN agencies by offering a basis for responsible businesses to align with the goals of the UN, providing a framework for furthering good practices, and helping to develop effective private and public sector policies and partnerships.

## **LEAD Board Programme**

It was announced that five companies will pilot the LEAD Board Programme, which aims to equip Boards of Directors to more effectively oversee the implementation of corporate sustainability strategies with a view to protect and support financial value creation. By embedding sustainability into its core duties, Boards of Directors are uniquely positioned to ensure the full mainstreaming of sustainability into corporate strategies and practices. World-class experts have been selected to facilitate the Board Programme, which is designed to be delivered in-house during regular Board meetings or retreats. Guided by the experiences of the pilot phase and the example set by LEAD companies, the Board Programme is expected to be made available to all other Global Compact participants with relevant governance models in the future.

# **Building the Coalition**

The Architecture is designed as an open invitation to organizations, initiatives and networks working globally to engage business on sustainable development. During the Closing Plenary, the Global Compact, WBCSD and GRI invited other like-minded organizations to join them in promoting and supporting the Architecture and taking actions that advance UN goals. This collaboration is based on a common understanding that i) corporate sustainability strategies must be rooted in respect for universal principles such as those advanced by the Global Compact in the areas of human rights, labour, environment and anticorruption; ii) that companies must adopt transparent processes for communicating to their stakeholders, applying standards such as those developed by the GRI; and iii) that corporate sustainability initiatives, platforms and networks, while focused on business, should also integrally involve key stakeholder groups.

# **Closing Remarks**

**UN Deputy Secretary-General Jan Eliasson** welcomed the outcomes of the Leaders Summit emphasizing that the two days have laid the foundation for a new level of business engagement with the UN. He highlighted Local Networks as the "soul and foundation" of the Global Compact and noted that they were a focal point throughout the Leaders Summit. He expressed support for the new issue platforms, progress made by existing Global Compact platforms and working groups, and the in depth analysis of Private Sustainability Finance presented at the Leaders Summit. The Deputy Secretary-General welcomed the commitments made at the UN Private Sector Forum, as well as the Global Compact's forthcoming Africa strategy. The Deputy Secretary-General made clear that the Leaders Summit can provide important inspiration to Governments as they debate the post-2015 agenda and encouraged business to express its willingness to engage to Governments. He thanked all participants on behalf of the Secretary-General and called them to become architects — and builders — of a better world. **66** Business is at the heart of improved living standards and well-being. 
# ACTION FAIR: LEARN. CONNECT. COLLABORATE.

The event explored the profound imbalances caused by the loss or waste of a third of global food production, due to both inefficient supply chains and by consumers - in households, markets, restaurants and hotels. In addition to the human cost, the session discussed the impact of food waste on the environment, which leaves a large carbon footprint and squanders natural resources that are already at serious risk of degradation and depletion. Apart from significantly improving the overall availability of safe and nutritious food for human consumption, the session also demonstrated that reducing food waste can have a substantial positive impact on the environment.

#### CHILD LABOUR PLATFORM: AN INTERNATIONAL LABOUR ORGANIZATION-GLOBAL COMPACT INITIATIVE

The event introduced the ILO-Global Compact Child Labour Platform (CLP), a cross-sectoral, membership-based forum for businesses to share learnings about tackling child labour in supply chains. With expert ILO support, the CLP will identify obstacles business faces in implementing Global Compact Principle 5 — based on the principles of the ILO Child Labour Conventions — catalyzing practical and, where appropriate, joint solutions. Panelists introduced current projects and trends in tackling child labour from a corporate sustainability perspective, followed by a roundtable discussion.

The session explored the prospective role of business in advancing policy objectives relating to increased access to water, sanitation and hygiene (WASH) services; improved water resources management and governance; efficient water use; and pollution reduction. The roundtable created a conversation around two sets of issues: the role of philanthropy in the post-2015 development agenda and creating an environment that catalyzes new forms of partnerships to meet global challenges.
